## Parking Smart

is a matter of turnover of on-street spaces for customers and visitors seeking downtown goods and services. In order to insure adequate parking turnover for customers, clients, and visitors, it's imperative that downtown workers park off-street.

The goal of the parking program is to provide long-term parking in off-street facilities and short-term parking on-street in time limited zones. This goal is accomplished by creating off-street parking opportunities (lots and decks) and generating on-street parking space turnover through timelimits and enforcement. Off-street lease spaces are available through the parking office and offered by private individuals. Daily public parking is available at the 3rd Avenue Deck and the 6th Avenue Deck. Parking is monitored daily by a Parking Officer.

If you have questions or comments about the program or need to lease a space, please call the parking office.

# PARKSMART

Chapter 12, Section 12-244,(b) of The Code of the City of Rome, Georgia states:

*No vehicle or motorcycle shall be parked more than three hours, whether consecutive or otherwise, in the downtown parking zone between the hours of 8am and 6pm, Monday through Saturday.*

## If you get a Ticket...

You must pay the appropriate fine within five (5) business days. After five business days, the fine doubles. A ticket not paid within 30 calendar days of the date of issue will subject you to a court summons.

Fines may be paid online at [DowntownRomeGA.us/parking](http://DowntownRomeGA.us/parking) or at the Customer Service Office, 601 Broad Street, City Hall, or mailed to P.O. Box 1433. Officer cannot collect fines. Rome City Municipal Court is held on the ground floor of the Rome/Floyd County Law Enforcement Center on West First Street.
